AGENT TERM AND CONDITIONS

1. **UZIE GOLD WORLDWIDE (“UGW”)** is a company that buy, sell and distribute **GOLD MERCHANDISE (“GM”)** to the public. Once a **CUSTOMER(“CUS”)** purchases our merchandise, the **CUS** will become **UZI GOLD WORLDWIDE AGENT (“UGWA”)**.
2. **UGW** has the right to appoint any **UGWA** to become our **UZI GOLD WORLDWIDE STOCKIST(“UGWS”)** or **UZI GOLD WORLDWIDE DEALER(“UGWD”)**.
3. **UGWA, UGWS** and **UGWD** is entitled to a certain commission that the **UGW** has to offer within our **UZI GOLD WORLDWIDE AGENT SYSTEM (“UGWAS”)**.
4. **UGW** is entitled to change the commission structure for all **UGWA, UGWS** and **UGWD**.
5. **UGWA, UGWS** and **UGWD** are **NOT ALLOWED** to use **UGW** name or receipts to sell or distribute merchandise other than **UGW GM**.
6. **UGWA, UGWS** and **UGWD** are **NOT ALLOWED** to use **UGW** name or receipts to buy from a stolen or suspected stolen **GM**.
7. **UGWA, UGWS** and **UGWD** are **NOT ALLOWED** to take any booking fee/full payment from **CUS**. All payments must be paid to **UGW** company account.
8. **UGWA, UGWS** and **UGWD** are **NOT ALLOWED** to manipulate other **UGWA, UGWS** and **UGWD** commission and all the commission in **UGWAS**.
9. **NON UGWA, UGWS** and **UGWD** are **NOT ALLOWED** to use all **UGW** logo, name, branding for promotion purpose before becoming official **UGWA, UGWS** and **UGWD**.
10. If there is **ANY** breach of terms and conditions, **UGW** is allowed to withdraw **UGWA, UGWS** and **UGWD** registration and all the commission without any prior notice.
11. **UGW** will **NOT** be responsible for any **UGWA, UGWS** and **UGWD** that breach **UGW** terms and condition. All legal action will be the responsibility of **UGWA** and **UGWS**.
12. **UGW** have the right to take legal action to any **UGWA, UGWS** and **UGWD** that breach **UGW** terms and condition.
13. When **UGWA, UGWS** and **UGWD** want to withdraw from **UGW**, **UGW** have the right **NOT** to give back any outstanding commission, service payment or delivery cost.
14. **UGW** will not be responsible for any third-party claims and **UGW** will deal only with official **UGWA, UGWS** and **UGWD**.
15. **UGWA, UGWS** and **UGWD** is responsible for maintaining good **UGW** name at all time.
16. **UGW** is entitled to change this terms and conditions without any prior notice.

UZI GOLD ENTREPRENEURSHIP PROGRAM (UEP)

1. **UEP** is a joint collaboration program between **UGW & UGWA**.
2. **UGWA AGREE** to give **UGW** their **GM** to be **SELL** and **TRADED** using **UGWAS**.
3. **UGW** will give **UGWA PROFIT SHARING (“PS”)** based on **UEP** type.
 - **UZI GOLD 6 MONTH ENTREPRENEURSHIP PROGRAM**
 - i. **UGWA** will receive 1.0% ~ 1.2% **WEEKLY PROFIT** based on the initial **GM** value for **24 WEEKS**.
 - **UZI GOLD 12 MONTH ENTREPRENEURSHIP PROGRAM**
 - i. **UGWA** will receive 1.2% ~ 1.5% **WEEKLY PROFIT** based on the initial **GM** value for **48 WEEKS**.
 - **UZI GOLD 24 MONTH ENTREPRENEURSHIP PROGRAM**
 - i. **UGWA** will receive 1.5% ~ 2.0% **WEEKLY PROFIT** based on the initial **GM** value for **96 WEEKS**.
4. **UGW** will transfer the **PS** to **UGWA Gold Commission Wallet (“GCW”)** after 7 days of joining **UEP**.
5. **PS** will be transferred to **UGWA GCW** every week until the **END** of **UEP**.
6. After **UEP END**, **UGWA WILL GET BACK** their **GM** based on initial **UEP WEIGHT VALUE ±**.
7. If the **GM** weight is **LESS**, then, **UGW** will compensate the value with **CURRENT COMPANY GM PRICE**.
8. If the **GM** weight is **MORE**, then, **UGWA** will compensate the value with **CURRENT COMPANY GM PRICE**.

BOOKING TERMS AND CONDITIONS

1. **UGW** is entitled to reject any **GM** booking without booking fee.
2. Full payments must be made after **GM** is ready with to be hand over to **CUS** by **UGWS** or **UGWD**.
3. Any booking cancellation from **UGWA**, **UGWS** and **UGWD** will be penalized 5% of the current **GM** price and the **CUS** will be will be blacklist from becoming **UGWA**, **UGWS** and **UGWD**.
4. **UGW** is entitled to change or edit this terms and conditions without any prior notice.

DELIVERY TERMS AND CONDITIONS

1. **GM** delivery is the responsibility of **UGWS** or **UGWD**.
2. If there are any problems when delivering **GM** to **CUS**, cost will be borne by **UGWS** or **UGWD**.
3. **UGW** is entitled to change this terms and conditions without any prior notice.
